



GENERAL VOLUNTEER CONSENT FORM FOR LIABILITY RELEASE AND IMAGE/PHOTO WAIVER

This Release and Waiver of Liability (the "Release") executed on today's date _____

Volunteer and/or Guardian understand that this Release discharges The Foundation from any liability or claim that the Volunteer and/or Guardian may have against The Foundation with respect to any bodily injury, personal injury, illness, death or property damage that may result from Volunteer's work for The Foundation, whether caused by the negligence of The Foundation or its officers, directors, employees, or agents or otherwise. Volunteer and/or Guardian also understand that The Foundation does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury or illness.

- 2. **Assumption of the Risk.** The Volunteer and/or Guardian understand that the work for The Foundation may include activities that may be hazardous to the Volunteer, including, but not limited to, use of tools as well as digging and lifting heavy objects, working around other participants who may not be accustomed to this type of labor. The Volunteer and/or Guardian hereby expressly and specifically assume the risk of injury or harm in these activities and release The Foundation from all liability for injury, illness, death or property damage resulting from the activities for the Volunteer's work for The Foundation.

- 3. **Photographic Release.** Volunteer and/or Guardian do hereby: consent that their photograph may be taken or their image digitally recorded while engaged in work for The Foundation and do hereby grant and convey unto The Foundation all right, title and interest in any and all photographic images and video or audio recordings made by The Foundation during the Volunteer's work for The Foundation, including, but not limited to, any and all copyrights, royalties, proceeds or other benefits derived from or associated with such photographs or recordings.
